



## Corporate Membership 2021

In recognition of the perfect opportunity that golf membership provides for small and medium sized businesses to impress clients, reward employees and do business in a premium, exclusive environment, Camelot has a Corporate Membership designed to meet those needs. The Corporation can benefit from associating with a premium golf club and marketing through networking, while having the ability to deduct expenses for guests. The membership is subject to the following qualifying criteria:

- This category is available to incorporated or limited companies with presentation of an active Master Business License or CRA Business Number.
- The Corporation can name up to a maximum of four (4) designates, who are affiliated directly with the Corporation, one of which must accompany any tee-time booking.
- Designates can be changed annually by advising the club office no later than April 30<sup>th</sup>
- The Corporation will hold an Associate Membership, thereby not hold a membership certificate in the club and there will be no voting privileges. If you are interested in a membership certificate, Corporations are eligible to purchase Regular Memberships. Please see separate terms and conditions.

This membership category is limited to 30 Corporations, granted on a first come first served basis, subject to revision and approval by the Board of Governors.

### Corporate Benefits:

- Existing Regular Members wishing to buy a Corporate Membership must surrender their Regular membership certificate and pay the Corporate initiation fee.
- Play will be permitted anytime on weekdays, but only after 11am on weekends/holidays
- Reciprocal play will only be allowed for Gold Members, with the round deducted from their annual total, or Platinum Members to a maximum of 5 rounds per season.
- Notwithstanding these restrictions, Corporate Members may fill any openings on the tee sheet in restricted times within 72 hours by contacting the Pro Shop.
- Corporate Members will be eligible to play in club events, with the exception of Club Championships and Intersectional Qualifying.
- One designated member can join Men's League at the Gold level and two at the Platinum level; Ladies' league is open to any female designated members.
- One designee will be provided a locker and club storage at the Bronze level, with an additional locker and club storage location provided per progressive level (i.e. 2 for silver, etc.), with no Member having more than 1 locker
- A Corporation may suspend playing privileges for one season with payment of a maintenance fee that provides club access.
- Complimentary year-round use of club meeting rooms or banquet space for functions.



## **Membership Initiation Fees and Medal Packages:**

The Corporation will be subject to an initiation fee of **\$15,000+HST, payable over 10 years interest free**. Alternatively, a Corporation can pay a one-time fee of **\$12,000+HST** up-front, earning a savings of 20%. Since this is an Associate membership, no Regular membership certificate will be provided. In addition, the Corporation will select from one of the following options:

**Platinum-Gold-Silver-Bronze:** The Corporation will choose between **20, 40, 60 or 100 rounds with shared electric cart** (valid for designates or guests). These rounds cannot be carried forward to a future season, nor split into 9-hole rounds. The pricing is as follows:

**Platinum (100 rounds) package -- \$9,000+HST with F&B minimum of \$2000**

**Gold (60 rounds) package -- \$5700+HST with F&B minimum of \$1500**

**Silver (40 rounds) package -- \$4800+HST with F&B minimum of \$1000**

**Bronze (20 rounds) package -- \$3300+HST with F&B minimum of \$500**

## **Other Applicable Fees:**

- A preferred Corporate Membership guest fee rate of **\$100+HST** for 18-holes plus shared electric cart will apply during peak season. A shoulder season rate will also be available.
- **Hole in one fee:** \$2.00 per hole in one billed monthly per designate when applicable
- **Golf Canada Card:** \$38.00+HST billed in May for each designate
- **Fees per additional employee added:**
  - **\$500+HST dues** (no extra F&B): Bronze-Silver-Gold package (platinum excluded) as a golfer sharing rounds
  - **\$250 F&B minimum increase only** (no dues) Corporate package (any level) as a social member not sharing rounds
  - **Customized packages where additional rounds are made available will be considered on a case by case basis**
