



## **Spousal Membership**

Camelot Golf & Country Club is a modern private Club. As such, family is central to our focus and is key in our Membership offerings. A Spousal Membership is available to the spouse of any Regular Member. This is a non-equity, non-voting Membership that offers unrestricted access to both the golf course and clubhouse facilities. You will be pleased to discover a welcoming Membership and many opportunities to participate in events, both competitive and social.

## **Membership Privileges**

- Unlimited access to Eastern Ontario's premiere golf course rated in Top 100 courses in Canada since 2016
- Complimentary use of an impeccably appointed Clubhouse
- Unlimited use of an expansive practice facility including a driving range, chipping area, bunker practice area & putting green
- Full locker located within a luxurious locker room
- Complimentary amenities including tees, pull carts, club storage and cleaning
- Concierge service providing for access to private Clubs throughout Canada
- Reciprocal golf & guest privileges

## **Spousal Entrance Fee:**

To enjoy the privileges associated with a Spousal membership at Camelot, an initiation fee is payable of \$5,000+HST when the other partner is already a Regular member. 20% of the fee is due upon application, with the balance spread over the next 6 years equally. These installments are non-refundable, but no promissory note is required committing to the full amount should you resign before the end of the payment plan. Alternatively, you may pay the initiation fee upon application and enjoy a 20% savings (\$4,000+HST).

## **Spousal Weekday**

This membership category offers Spousal Members (Associate Members) the option of reduced playing privileges for reduced fees. Spousal Members will NOT be included in the cap on Weekday Members, subject to revision by the Board of Governors.

### **Membership Privileges**

- Unlimited access to the tee Monday to Friday, with the exception of holidays
- Weighting system for tee-time lotteries to give second priority (first priority given to fully privileged Regular or Spousal members)
- No access to the course included on weekends or holidays
- Only exception being participation in **either** the Regular or Senior Club Championship events that may occur during those restricted play periods
- Twice per season Weekday Spouses can play, without payment of applicable guest fees, during guest permitted times on a weekend or holiday, by booking with the Pro Shop.
- Unrestricted, complimentary use of Clubhouse
- Unlimited use of practice facility
- Full locker, club storage and concierge service
- Complimentary amenities including tees, pull carts, club storage and cleaning
- Reciprocal golf & guest privileges, with access restrictions as applicable at Camelot

## **Spousal Entrance Fee:**

To enjoy the privileges associated with a Spousal membership at Camelot, an initiation fee is payable of \$5,000+HST when the other partner is already a Regular member. 20% of the fee is due upon application, with the balance spread over the next 6 years equally. These installments are non-refundable, but no promissory note is required committing to the full amount should you resign before the end of the payment plan. ## **Limited Membership**

This is a round restricted golf membership for spouses at Camelot, who may want limited access to the golf course, while retaining full social privileges. Members in this classification may be 'Regular' Members if they own a membership certificate, otherwise they are classified as 'Associate' Members.

This classification is available to a spouse or partner of an active Regular Member, regardless of whether they hold a membership certificate, on a continual basis. At least one spouse must hold a Premium or Weekday membership for the spouse to qualify as a Limited Member.

### **Privileges:**

This membership classification provides the following benefits:

- 25 rounds of golf per season (One tee-time equals 1 round)
- There are no restrictions of tee times or dates
- Full locker located within a luxurious locker room
- Complimentary amenities including tees, pull carts, club storage and cleaning
- Use of all Camelot facilities such as the practice facilities & clubhouse
- Participation in club events (count as 1 round of golf)
- This membership is not eligible for the Club Championship nor being a member of an Intersectional Team.
- Nine & Dine events, that appear on the official golf calendar, do not count as a round

## **Spousal Entrance Fee:**

- Capital Improvement Fee 2: \$100+HST (Billed monthly over 12 months)



## **Spousal Social Category**

Any members Spouse may have a social membership at no charge.

## Spouses of a Regular member will have:

- Their individual account and be bound by all the regulations of the Club.
- Not be liable for dues, house minimum charges, nor special levies.
- Have clubhouse and practice area access and privileges
- May golf up to 5 times a year at no cost at restricted times
- This play restricted to Thursday/Friday after 6pm and after 4pm on Weekends/Holidays
- The Spousal Social member must be accompanied with their Spouse for their round

### Spouse of an Associate member will have:

- Their individual account and be bound by all the regulations of the Club.
- Not be liable for dues, house minimum charges, nor special levies.
- Have clubhouse privileges
- Play up to 5 times per season during guest times, with payment of applicable fees
