



Corporate Membership

In recognition of the perfect opportunity that golf membership provides for small and medium sized businesses to impress clients, reward employees and do business in a premium, exclusive environment, Camelot has a Corporate Membership designed to meet those needs. The Corporation can benefit from associating with a premium golf club and marketing through networking, while having the ability to deduct expenses for guests.

The membership is subject to the following qualifying criteria:

- ☑ This category is available to incorporated or limited companies with presentation of an active Master Business License or CRA Business Number.
- ☑ The Corporation can name up to a maximum of four (4) designates. Eligible designates must provide proof of employment of the corporation. One designate must form part of any tee-time booking.
- ☑ Designates can be changed annually by advising the club office no later than April 30th
- ☑ The Corporation will hold an Associate Membership, thereby not hold a membership certificate in the club and there will be no voting privileges. If you are interested in a membership certificate, Corporations are eligible to purchase Regular Memberships. Please see separate terms and conditions.

This membership category is limited to 30 Corporations, granted on a first come first served basis, subject to revision and approval by the Board of Governors.

Corporate Benefits:

- ✓ Play will be permitted anytime on weekdays, but only after 11am on weekends/holidays
- ✓ Reciprocal play will only be allowed for Gold or Platinum Members, with the round deducted from their annual total.
- ✓ Notwithstanding these restrictions, Corporate Members may fill any openings on the tee sheet in restricted times within 72 hours by contacting the Pro Shop.
- ✓ A maximum of one (1) delegate per corporation will be eligible to participate in our Club Championship and Intersectional Qualifying.
- ✓ One (1) designate member can join Men's League at the Gold level and two (2) delegates at the Diamond & Platinum levels; Ladies' league is open to any female designated members.
- ✓ One (1) designate will be provided with a locker and club storage at the Gold level, with an additional locker and club storage location provided at the Diamond & Platinum levels (2). Additional lockers may be rented. (Based on availability)
- ✓ A Corporation may suspend playing privileges for one season with payment of a maintenance fee that provides club access. (Non-playing membership at the price of \$1635 + \$500 F&B min. spend)



Corporate Initiation Fee & Medal Packages:

The Corporation will be subject to an initiation fee of **\$25,000+HST**.

20% of the fee is due upon application, with the balance spread equally over the next 6 years.

Alternatively, a Corporation can pay a one-time fee of **\$20,000+HST** up-front, earning a savings of 20%.

Since this is an Associate membership, no Regular membership certificate will be provided.

In addition, the Corporation will select from one of the following options:

Medal Packages:

The Corporation will choose between **60, 80, or 100 rounds, including one shared electric cart** (valid for designates or guests).

These rounds cannot be carried forward to a future season, nor split into 9-hole rounds.

The pricing is as follows (excluding HST):

Other Applicable Fees:

- **Corporate guest fees:** A preferred rate of **\$135+HST** for 18-holes plus shared electric cart will apply during peak season.
- **Hole in one fee:** A flat fee of \$25 will be charged at the start of the season and will be replenished to the same amount throughout the season, if need be.
- **Golf Canada Card:** \$43.00+HST billed in May for each designate (subject to change)
- **Fees per additional employee added:**
 - Annual dues of **\$500** + HST per additional designate as a golfer sharing rounds
 - A minimum spend of **\$250** + HST is required if an additional corporate social member is added (no dues)
